#### 2. Consider and act on the approval of the July 2016 Minutes

The Minutes from the July 2016 meeting were distributed and read by email before the meeting. A motion to approve the minutes was made by Robert and 2nd by Marie. Motion was approved unanimously.

# 3. Election of New Board Officers and determine signers on Bank Accounts

Possible projects include Painting and Screen door replacement.

Stacy mentioned that there were funds from CDBG which possibly could be used for updating the plumbing to the units. We will consider and determine scope and cost for such.

Councilman Tim Nelson spoke to the board on the need for more low income housing in Frisco.

NOW, THEREFORE, BE IT RESOLVED BY THE FRISCO HOUSING AUTHORITY FOR THE CITY OF FRISCO TEXAS

Whereas HUD and Congress have enacted in the 2014 Appropriations Act- HUD NOITICE PIH 2014-12(HA) changes to Flat Rent Requirements.

Whereas HUD requires an Amendment for the new Flat Rents.

Whereas the Flat Rents have increased.

Whereas the Frisco Housing Authority desires to keep their Utility Allowances current with changing costs and requirements

Section I.

That the Frisco Housing Authority Board of Commissioners authorizes the approval of the Flat Rent Significant Amendment for The Frisco Housing Authority

#### Section 2:

That the Frisco Housing Authority Board of Commissioners authorizes the approval of the new Flat Rents for 2017 in accordance with the policy noted above and that flat rents will not be lower than 80% of year current FMR minus the utility allowance appropriate for unit size.

#### Section 3:

That the Frisco Housing Authority Board of Commissioners authorizes the approval of the Utility Allowances and to keep the Utility Allowances current according to HUD regulations.

#### Section 4:

This Resolution shall take effect immediately upon its passage. RESOLVED THIS THE 7th day of December, 2016.
